

Terms Of Reference FOR THE PROCUREMENT OF FIREWALL LICENSE FOR THE PHILIPPINE GUARANTEE CORPORATION

A. BACKGROUND

The Philippine Guarantee Corporation (PhilGuarantee) in its continuous effort to fight the increasing threat of cybercrime, requires to upgrade and update its existing firewall infrastructure in order to continuously protect its network perimeter's defense as well as to increase the security for those working on a remote environment or on a Work From Home setup, by providing an encrypted connection.

B. PROJECT DESCRIPTION

This project is for the supply of license, support, patches, updates, and firmware upgrade of the existing firewall for PhilGuarantee for one year.

C. APPROVED BUDGET FOR THE CONTRACT

The Approved Budget for the Contract (ABC) is **Five Hundred Eighty Five Thousand Pesos** (Php 585,000.00) inclusive of all taxes and charges.

D. QUALIFICATIONS OF BIDDER

1. The Bidder should be duly authorized by the manufacturer/distributor to provide, sell, configure and support the firewall and management appliance.

The certification from the manufacturer/distributor authorizing the prospective bidder to provide such a product should be submitted together with the bid proposal. Bid proposals that do not include the Certification shall not be accepted/considered for award.

- 2. The Bidder must have the capacity to escalate product technical issues directly to the manufacturer.
- 3. Any and all costs necessary for the bidder to fulfil the project requirements in section B of this document shall be deemed included in the financial proposal. Any cost incurred in the fulfilment of the obligations but were not included in the financial proposal shall be shouldered by the bidder with the lowest complying bid.

E. DELIVERY PERIOD AND PLACE OF DELIVERY

The winning bidder shall supply an activated license if necessary within Five (5) calendar days (5 c.d.) from receipt of the Notice to Proceed at the PhilGuarantee Office located 23rd Floor BPI PhilAm Life Building, Ayala Ave, Makati City or via EMail.

F. ACCEPTANCE

The PhilGuarantee will inspect, test and evaluate the software prior to acceptance.

G. PAYMENT TERMS

Thirty calendar days (30 c.d.) upon acceptance
