WHEREAS, the FGSD determined that Philcopy Corporation is the exclusive distributor in marketing and servicing Kyocera Document Solutions brand copiers, laser printers, and multifunctional peripherals, including related consumables and spare parts in the Philippines as evidenced by as Sworn Certificate of Guarantee Exclusive Distributorship dated March 31, 2023;

WHEREAS, Philcopy Corporation submitted its quotation on March 22, 2023 at 4:38 P.M. before the deadline of March 28, 2023; 10:00 A.M. in the amount Pesos: One Million Seven Hundred Thirty Thousand Eight Hundred Fifty (Php1,730,850.00), inclusive of applicable taxes;

WHEREAS, the FGSD recommended the award of contract to Philcopy Corporation (copy of the memorandum dated March 24, 2023 herein attached as Annex A);

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:
