**WHEREAS**, Strategy Management and Communications Department (SMCD) requested the Bids and Awards Committee (BAC) for the procurement of the following items:

**WHEREAS**, CFA:093-2023 in the amount of **Pesos: One Hundred Ninety-Nine Thousand (Php199,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023 – Updated as of June 30, 2023, viz:

**WHEREAS**, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

**WHEREAS**, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required

postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

**WHEREAS**, the Request for Quotations (RFQ) were posted and sent on July 20, 2023 to the following suppliers:

1. Avid Sales Corporation;
2. Henry's Professional Photo Marketing Inc.;
3. CameraHaus; and
4. Infomax Enterprise.

**WHEREAS**, the following suppliers submitted quotations before the deadline of July 25, 2023; 10:00 A.M. (Lots 1 to 5);

1. Avid Sales Corporation received on July 20, 2023, 3:42 P.M.; and
2. BayanPC Technologies, Inc. received on July 25, 2023, 9:42 P.M.

**WHEREAS**, the SMCD in its Memoranda dated August 2, 2023, determined the following:

**WHEREAS**, Section 31.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

“The ABC shall be the upper limit or ceiling for acceptable bid prices. If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically disqualified. There shall be no lower limit or floor on the amount of the award.”

**WHEREAS**, Section 35.1 (c) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”

**NOW THEREFORE**, in consideration of the recommendation of the Strategy Management and Communications Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:


