

## CONTRACT FOR CONSULTING SERVICES

This Contract Agreement (**Contract**) is made and executed on 19 JUN 2023 of May 2023 by and between:

**PHILIPPINE GUARANTEE CORPORATION (PHILGUARANTEE)**, with principal office at 6811 BPI-Philam Life Makati, Ayala Avenue, Salcedo Village, Makati City represented by its authorized signatory, MR. ALBERTO E. PASCUAL, President and Chief Executive Officer, whose authority is evinced by the Secretary's Certificate attached as Annex A;

- and -

**ELIAN MANAGEMENT CONSULTING SERVICES (EMCS)** with principal office at B61 L18 Bonifacio Drive, Holiday Homes Subd., Brgy. Biclatan, General Trias, Cavite, herein represented by its duly authorized signatory, MS. MYQUEL M. REGALADO, Co-founder/Senior Consultant, whose authority is evinced by the Secretary's Certificate attached as Annex B;

PHILGUARANTEE invited Proposals for the **Procurement of Training and Consultancy for the Maintenance of the Certification of the Integrated Management System (IMS)** to be completed in six (6) months or earlier from the date of the receipt of Notice to Proceed;

EMCS submitted the single rated and responsive proposal in the sum of **Pesos: Seven Hundred Eighty-Seven Thousand (Php787,000.00)**, inclusive of applicable taxes based on the requirement specified in the Terms of Reference;


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Request for Proposal;
  - ii. Terms of Reference;
  - iii. Winning bidder's bid, including the Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Entity 3.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this contract in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


