WHEREAS, the GFPS-Technical Working Group (GFPS-TWG) requested the Bids and Awards Committee (BAC) for the procurement of **Meals for Online Gender Sensitivity Training** with an Approved Budget for the Contact (ABC) in the amount of **Pesos: One Hundred Fifty-Five Thousand Eight Hundred (Php155,800.00)**, inclusive of all applicable taxes;

WHEREAS, pursuant to BAC Resolution 2023-126, the HOPE approved the use of Negotiated Procurement-Small Value Procurement for the procurement of Meals for Online Gender Sensitivity Training with an Approved Budget for the Contact (ABC) in the amount of Pesos: One Hundred Fifty-Five Thousand Eight Hundred (Php155,800.00), inclusive of all applicable taxes;

WHEREAS, CFA:124-2023 in the amount of **Pesos: One Hundred Fifty-Five Thousand Eight Hundred (Php155,800.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023-Updated as of June 30, 2023, viz:

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Requests for Quotations (RFQ) were posted and sent on August 24, 2023 to the following suppliers:

1. Hizon's Restaurant & Catering Services Inc.;
2. M Catering & Fine Foods; and
3. Max's Kitchen, Inc.

WHEREAS only Max's Kitchen, Inc. submitted its quotation on August 29, 2023; 5:00 P.M. before the deadline of August 30, 2023; 10:00 A.M. (PhST):

WHEREAS, the GFPS-TWG determined that the quotation of **Max's Kitchen, Inc.** in the amount of **Pesos: One Hundred Forty-Four Thousand Four Hundred (Php144,400.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated August 30, 2023 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the GFPS-Technical Working Group (GFPS-TWG), the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the award of contract to **Max's Kitchen, Inc.** for the procurement of **Meals for Online Gender Sensitivity Training** in the amount of **Pesos: One Hundred Forty-Four Thousand Four Hundred (Php144,400.00)**, inclusive of applicable taxes
