**RESOLUTION NO. 2023-184**

**WHEREAS**, the Enterprise Risk Management Office (ERMO) requested the Bids and Awards Committee (BAC) for the procurement of **Consultancy Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Nine Hundred Ninety-One Thousand Three Hundred Thirty (Php991,330.00)**, inclusive of applicable taxes;

**WHEREAS**, pursuant to BAC Resolution 2023-117, the Head of the Procuring Entity approved the adoption of Small Value Procurement for the said procurement;

**WHEREAS**, the CFA:091-2023 in the amount of **Pesos: Nine Hundred Ninety-One Thousand Three Hundred Thirty (Php991,330.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023 – Updated as of June 30, 2023, viz:

**WHEREAS**, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

6. Imaginet International Inc.; and
7. Rosehall Management Consultants Inc.

**WHEREAS**, only PMF Professional Advancement and Continuing Education submitted its proposal on August 11, 2023, 9:38 A.M. before the deadline of August 11, 2023; 10:00 A.M. (PhST);

**WHEREAS**, ERMO in its Memorandum dated September 27, 2023 determined that the proposal submitted by PMF Professional Advancement and Continuing Education was not responsive to the requirements of the Corporation and requested for the declaration of a failure of bidding and reposting of the Request for Proposal;

**WHEREAS**, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”


**NOW THEREFORE**, in consideration of the recommendation of the Enterprise Risk Management Office, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of **Consultancy Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Nine Hundred Ninety-One Thousand Three Hundred Thirty (Php991,330.00)**, inclusive of applicable taxes; and



To post the new Request for Proposal for the procurement of **Consultancy Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Nine Hundred Ninety-One Thousand Three Hundred Thirty (Php991,330.00)**, inclusive of applicable taxes.
