NOW THEREFORE, for and in consideration of the foregoing premises, the Parties have agreed as follows:

- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Winning bidder's proposal;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - Other related documents in relation to the bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Pesos: One Hundred Sixty Thousand (Php160,000.00), inclusive of applicable taxes, to be paid by PHILGUARANTEE, HIZON'S RESTAURANT AND CATERING SERVICES, INC. agrees to provide the Meals for its Anniversary Celebration in conformity with the documents required under RA 9184 and this Contract.
